As George Washington put it, their biggest problem was “no money.” In 1789 A.D. the Constitution of the United States became the supreme law of the land “in Order to form a more perfect Union.” Still the basis of the entire USA government, the Constitution is the oldest charter of supreme law in use. Due to the government's vastly expanded power under the Constitution, the Bill of Rights was put in place to prevent Congress from abusing its powers.
